# Camp Alexander Mack, Inc.

Dear Parents,

Throughout the COVID-19 pandemic, Camp Mack has used many sources to make decisions regarding the safety and health of campers, guests, and staff. We have consulted the latest advice from the Centers for Disease Control, Indiana State Department of Health, the Kosciusko County Health Department, and the American Camp Association. We have also talked to our guests and many parents regarding their thoughts about what it takes to be safe at camp. This has been very successful as there have been no COVID cases related to camp from any guest or staff over the last fourteen months.

We have also noticed over the last few weeks, a change regarding the opinions expressed by doctors and epidemiologists as more and more people have been vaccinated and the rates of infection have decreased. It was not surprising to us that recommendations regarding outdoor activities and masks changed late last week.

At this point, nearly everyone over the age of sixteen who wants a vaccination has been able to receive one. Soon that will be true for children between twelve and sixteen as well. However, we have many campers who are under the age of twelve each year that will certainly not be vaccinated. The science tells us that children are at much lower risk of severe disease, and they do not appear to spread the virus as easily as adults. Yet it is important for us to do everything we can to provide a full camp program that is as safe as possible for all. For this reason, we want to update you on two of our precautions for this summer.

First, we will continue to require masks when campers, staff, or guests are in the John Kline Welcome Center or any of our lodges. Masks will be optional in cabins or out of doors, unless campers are interacting with people from another family group for ten minutes or longer without physical distancing. This means that active games, swimming, boating, hiking, challenge activities, campfires, and worship will not require masks. Only if people from two or more groups will be in close contact for longer than ten minutes will masks be required. A camper may always choose to wear a mask.

Secondly, our pre-camp screening requires a camper to provide one of three documents when arriving at camp in addition to the other paperwork we normally require. A camper must provide either:

1. proof of full COVID-19 vaccination, **or**
2. a negative COVID-19 rapid test result taken within three days of arrival (either Friday, Saturday, or Sunday), **or**
3. a completed two-week Camper Covenant (attached)

When your camper arrives, he or she will provide this documentation, turn in other paperwork and medications, and pass the normal health screening. Once this is completed, you will drive your camper to their cabin area and present a pass to the team leader who will complete your check-in. Parents will assist campers in removing luggage, bedding, and other items from the car, but they will not be allowed to go to the cabin. A member of the staff will help campers get their "stuff" to the cabin.

We are excited that we can provide the full joy of summer camp this year, and with these few adjustments, it should be a safe and rewarding experience for everyone. Please contact me at Camp Mack if you have any additional questions or concerns. Thank you for being part of the Camp Mack community.

## Camper Pre-Camp Covenant

Camp Mack provides a sanctuary where people connect with God, experience creation, and build Christian community. God calls us to love one another and to care for each other in communities of faith. This is how we create a sanctuary – a place of safety and worship.

Because most children and some adults who will attend camp are not vaccinated, it is essential that we take precautions before camp begins to monitor ourselves and our activities. If there is a possibility that we have been exposed to or have contracted the virus, then we must stay away from camp for the safety of others. **Please complete and sign this form. We will ask you to turn it in during registration.**

Check one of the three options below:

\_\_\_\_\_ I have been fully vaccinated against the COVID-19 virus and will provide a copy of the vaccination record to camp staff. (To be fully vaccinated requires that the last required dose of your vaccine be administered two or more weeks prior to the start of camp.)

\_\_\_\_\_ I have a negative COVID-19 test result from a test administered no earlier than the Friday before my camp begins and will provide a copy of the test result to camp staff.

\_\_\_\_\_ I have monitored my child's health and activity over the last two weeks, and:

- He/she has not experienced a fever over 100 or chills, unusual cough, unusual shortness of breath, unexplained fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, unusual congestion or runny nose, nausea or vomiting, or diarrhea in the last 48 hours.
- He/she has not tested positive for COVID-19 in the last ten days
- He/she has not been in close physical contact with anyone who has tested positive for COVID-19 or anyone who has symptoms of COVID-19 in the last fourteen days.
- He/she has avoided large indoor crowds in the last fourteen days.
